

**OREGON INTERSCHOLASTIC SKI RACING ASSOCIATION
NORDIC VOLUNTEERS ASSUMPTION OF RISK, WAIVER OF LIABILITY, AND COVID-19/COMMUNICABLE
DISEASE AGREEMENT**

READ CAREFULLY BEFORE SIGNING. THIS FULL RELEASE IS AN ENFORCEABLE CONTRACT BETWEEN YOU AND OREGON INTERSCHOLASTIC SKI RACING ASSOCIATION, AN OREGON NONPROFIT CORPORATION WITH 501(c)(3) STATUS (“OISRA”). IT INCLUDES A RELEASE OF LIABILITY AND WAIVER OF CERTAIN LEGAL RIGHTS. THIS FULL RELEASE COVERS ALL COACHING AND OTHER VOLUNTEER WORK AND ACTIVITIES AND PROGRAMS OF ANY SORT CONNECTED WITH OISRA, INCLUDING BUT NOT LIMITED TO INSTRUCTION, TRAINING, AND COMPETING IN NORDIC SKIING, ALPINE SKIING, AND FREESTYLE/SLOPESTYLE (“ACTIVITIES”) YOU PARTICIPATE IN FROM THE DATE YOU SIGN BELOW TO END OF MARCH 2022.

The novel coronavirus (“COVID-19”) has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. While rules, guidance, and personal discipline may reduce this risk, the risk of serious illness and death does exist. **Oregon Interscholastic Ski Racing Association (“OISRA”) cannot completely mitigate the transfer of communicable diseases like COVID-19. Coaching for OISRA includes possible exposure to and illness, injury, or death from communicable diseases, including COVID-19.**

I attest that I will be vaccinated against Covid-19 or I will follow the Oregon Health Authority (OHA) and OISRA guidelines for applying for exception due to medical or religious reasons.

I further attest to the following:

- If I develop symptoms (fever, chills, cough, shortness of breath, loss of taste/smell), I agree that I will refrain from engaging in coaching (other than any exclusively online activities) with OISRA and not otherwise participate in any OISRA activities.
- I acknowledge that I must follow the safety and hygiene protocols set forth by the Centers for Disease Control, Oregon Health Authority, and OISRA, and not return to coaching until I meet their health guidelines.
- I will notify OISRA if I receive a COVID-19 diagnosis, test positive for COVID-19, or am advised to self-quarantine due to concerns related to COVID-19 or another communicable disease
- I do and will follow the Center for Disease Control and Oregon Health Authority COVID-19 guidelines to the best of my ability (e.g., hand washing, physical distancing, wearing of face coverings)

I also acknowledge and agree that, due to the nature of OISRA activities, social distancing of six (6) feet per person among student athletes, myself, and others is challenging in the best circumstances. I fully understand and appreciate both the known and potential dangers of coaching for OISRA and acknowledge that the student athletes, myself, or others may, despite all reasonable efforts to mitigate such dangers, result in exposure to COVID-19, which could result in quarantine requirements, serious illness, disability, and/or death. Additionally, I acknowledge and agree that it shall be my responsibility to ensure that all student athletes and others participating in OISRA activities for which I am responsible have provided a liability waiver for communicable diseases, such as COVID-19, to OISRA, and shall use all reasonable efforts

to exclude individuals from a reasonable area around OISRA activities for which I am responsible if they have not provided such a waiver.

I understand that my coaching activities with OISRA may involve activities that could be hazardous to me, including those which may expose me to communicable diseases such as COVID-19. I fully understand and appreciate these risks that are inherent to coaching student athletes. I assume the risk of all bodily injury, medical treatment, illness, and/or death that may result from my coaching for OISRA, even if it results from OISRA's negligence or that of its employees or agents, other than that which occurs as a result of gross negligence, wanton or willful misconduct, or reckless or intentional conduct, to the fullest extent allowed by law. Additionally, I assume the risk of liability which may arise due to my failure to follow and enforce the safety and hygiene protocols set forth by the Center for Disease Control, Oregon Health Authority, and OISRA, or that which arises from my failure to use all reasonable efforts to exclude individuals from a reasonable area around OISRA activities for which I am responsible if they have not provided a liability waiver for communicable diseases, such as COVID-19.

I hereby release, waive, discharge, exonerate, and agree to indemnify and hold harmless OISRA, its Board of Directors, the individual members thereof, and all officers, agents, employees, volunteers, and representatives, or any of the student athletes or other participants and their family or guests, from any and all liability, causes of action, claims, demands, damages, expenses and compensation, including attorneys' fees, fines, or other costs arising out of any exposure to or illness or injury from a communicable disease, including COVID-19, which may result from or have any connection to my coaching or other matters set forth herein, other than that which occurs as a result of gross negligence, wanton or willful misconduct, or reckless or intentional conduct of OISRA or other indemnities, to the fullest extent allowed by law. I give this release to the fullest extent of the law, for myself, and my heirs, administrators, executors, successors and/or assignees.

I certify and represent that I have the legal authority to waive, discharge, release, indemnify, and hold harmless the released parties.

I certify that I have read this document in its entirety and fully understand its contents. I agree to OISRA's Nordic Volunteer Assumption of Risk, Waiver of Liability & COVID-19 Agreement. I freely and voluntarily assume all risks of such hazards and notwithstanding such, release OISRA and the other released parties from all liability for any loss or claims arising from my coaching for OISRA, including loss or claims that arise from negligence of the released parties, other than that which occurs as a result of gross negligence, wanton or willful misconduct, or reckless or intentional conduct, to the fullest extent allowed by law.
